2. Release of Liability

To the fullest extent permitted by law, the Client hereby releases, waives, and discharges Fancy

Flush Restroom Rentals, its owners, employees, agents, and affiliates from any and all liability,

claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or

death that may be sustained by any person or property during the use of or access to the rental

equipment.

3. Conditions Not Covered

This waiver specifically includes, but is not limited to, liability resulting from:

- Accidents due to wet, icy, or uncleared stairs, steps, or ramps.

- Injuries resulting from improper use, misuse, or vandalism of the trailer.

- Harm caused by failure to follow instructions for safe use.

- Damage or injury resulting from weather conditions including wind, snow, ice, rain, or extreme

temperatures.

- Accidents or injuries caused by unlevel or unstable ground conditions where the trailer is placed.

- Claims arising from equipment not maintained to a standard beyond normal wear and tear.

4. Client Responsibilities

The Client agrees to maintain the safety and security of the trailer area, including but not limited to:

- Keeping the access and surrounding areas clear of hazards such as snow, ice, mud, and debris.

- Preventing unauthorized or unsafe use of the trailer.

- Monitoring usage during the event if no attendant is provided.

- Notifying the Company immediately of any issues, malfunctions, or safety concerns.
